## **HWRD Rule Quiz** 10 points out of 10 100% (OPTIONAL) What is your email? True or False. Regarding harassment of officials, the referee is required to assess a minor penalty before assessing a misconduct or game misconduct penalty. (Rule 11.1a) True, the player or coach has a right to receive a lesser penalty before a more severe penalty. False, the referee may assess which ever penalty is deemed fit. False, the referee must give a verbal warning before assessing whatever penalty is appropriate for the second incident of maltreatment A player on a breakaway in the neutral or attacking zone is fouled from behind and the referee signals a penalty shot. Before the play is completed a second infraction is signalled against the same team, whether it be to the same player or a Correct different player. The penalty shot is assessed for the first infraction (i.e. the foul from behind). Is the penalty for the second infraction still assessed? (Interpretation 2, Rule 4.11) Yes, if there is no goal scored on the penalty shot. Yes. The second penalty is always assessed regardless of whether a goal is scored on the penalty shot. No. The second penalty is not assessed because it happened after the penalty shot infraction. A player skates backwards over the blue line with the puck; that player's skates clearly enter the zone before the puck does. Is the player offside? (Rule 6.12c-i)

Is this icing or not? (Rule 6.7 **Interpretation 6)** Icing. The last player to touch the puck. was team A on team A's side of the ice. Not icing. Team A can not be held. responsible for the puck striking a team B player on the team A side of the ice. Team B has 1:42 left in a penalty when they are assessed a penalty shot against them. Team A scores. Does the goal on the penalty shot cancel the penalty with 1:42 left? (Rule 4.11, Interpretation 10) Only if there is less then 1 minute left in the penalty. Yes, the penalty shot goal cancels the penalty as well. No. The goal was not scored on the power play. It was scored on a penalty shot. Only if it is a minor penalty. If the1:42 is a major then the goal does not cancel it. At the same stoppage A3 is assessed a 5+GM (served by A4) and A6 is assessed a minor penalty. During the 5:3 power play, B55 scores a goal.
